


Dublin City Schools 2024 Redistricting Study

Public Information Session 2 Survey Results



Online Survey Results

Introduction

The Dublin City Schools internal planning team and staff hosted a public information session on October 21, 2024. Cropper GIS facilitated the meeting and shared information about the planning team goals, guidelines, and process and introduced an elementary and middle school DRAFT option developed by the planning team that help to meet the redistricting study goals. The public then asked staff and planning team members questions about the process and the options under consideration. Schools continued outreach efforts following the public information session encouraging participation in the online survey.

Online Survey

Six-hundred thirty (630) respondents participated in the online survey that was available to the public from October 21, 2024, until November 3, 2024. The survey asked respondents to provide their thoughts, observations, and overall opinion on the DRAFT options that were presented at the October 21, 2024, public information session and posted on the DCS redistricting web site. The data – aggregated, summarized and reported below – is intended to be used by the internal planning team as a tool to help facilitate their deliberation and decision-making regarding the redistricting process. The results of the survey alone do not constitute a decision regarding a boundary change and are not intended to be used in the decision-making process independent of other information, discussion, and deliberation.

In order to gain a better understanding of where the majority of the respondents are coming from throughout the district, the respondents were asked "What elementary school zone do you live in for the current school year?"

Option Summary Tables for All Submitted Comments

Options Opinion Summary

When asked 'What is your opinion of an option?' 30.7% of respondents said they approved of the ES DRAFT Option and slightly more (33.2%) approved of the MS DRAFT Option. The MS DRAFT Option elicited a stronger response overall, with 27.5% opposing and only 15.3% remaining neutral, compared to 19.4% opposing the ES DRAFT Option and 31.7% remaining neutral.
